Field Trip Participation Agreement

Name and Likeness Release

Participant assigns to Sponsor all rights, title, and interest, including full rights of assignability, in any and all media in which Participant’s Likeness has been captured in connection with the Event.

Assumption of Risk

Participant understands and agrees that participation in the Event carries a degree of risk to person and property. In particular, Participant understands that he/she may be touring land or properties that are undeveloped, developed or under development or construction, and that such activities may involve the risk of serious injury, illness, permanent disability, dismemberment and death, and may also involve the risk of severe economic harm and property loss and damage. Participant understands that these risks may result from the action, negligence and/or failure to act by Participant and/or others including but not limited to other participants, Sponsor, third party organizers and/or volunteers. Liability Release and Indemnity Agreement

Medical Treatment
