### Assumption of Risk

Participant understands and agrees that participation in the Event carries a degree of risk to person and property. In particular, Participant understands that he/she may be touring land or properties that are undeveloped, developed or under development or construction, and that such activities may involve the risk of serious injury, illness, permanent disability, dismemberment and death, and may also involve the risk of severe economic harm and property loss and damage.
