Participation Agreement

Participant assigns to Sponsor all rights, title, and interest, including full rights of assignability, in any and all media in which Participant’s Likeness has been captured in connection with the Summit.

Assumption of Risk

Participant understands and agrees that participation in the Summit carries a degree of risk to person and property. In particular, should Participant elect to attend the optional field trip, Participant understands that he/she may be traveling by small boat, plane or bus, and/or touring land that is undeveloped, developed or under development, and that such activities may involve the risk of serious injury, illness, permanent disability, dismemberment and death, and may also involve the risk of severe economic harm and property loss and damage. Liability Release and Indemnity Agreement

Medical Treatment
